Invitation to Apply for Eligibility and to Bid

The Local Government Unit of Villaverde, through its Bids and Awards Committee (BAC), invites suppliers/manufacturers/distributors/contractors for eligibility and to bid for the hereunder contract:

Place of Delivery	:	Municipal Hall, Poblacion, Villaverde, Nueva Vizcaya
Approved Budget for the Contract	:	P 122,129.66
Source of Funds	:	MLGU General Fund & 20% Development Fund and Capitation Fund
Contract Duration	:	30 Calendar Days

Prospective bidders should have experience in undertaking a similar project within the last two (2) years with an amount of at least 50% for the proposed project for bidding. The Eligibility Check/Screening as well as the Preliminary Examination of Bids shall use non-discretionary "pass/fail" criteria. Post-qualification of the lowest calculated bid shall be conducted.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

Complete set of Bidding Documents maybe purchased by interested eligible Bidders upon payment of non-refundable amount of **Five Hundred Pesos (P 500.00)** per set of Bidding documents to the Municipal Treasury Office.

The Local Government Unit of Villaverde reserves the right to reject any or all bids to waive any required formality and award the contract to any bidder whose proposals as evaluated by the BAC is the most advantageous to the government. The Local Government Unit of Villaverde assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids, or does it guarantee that an award will be made.
