**Invitation to Bid for the**  
**CORE LOCAL ROAD**  
**CONSTRUCTION/MAINTENANCE/REHABILITATION**

1. The **LGU VILLAVERDE**, through the **Local Government Support Fund (LGSF) 2015** intends to apply the sum of **Two Million Four hundred Ninety Nine Thousand Eight Hundred Ninety Two & 62/100 (P2,499,892.62)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **CORE LOCAL ROAD CONSTRUCTION/MAINTENANCE/REHABILITATION**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **LGUVILLAVERDE** now invites bids for *Concreting of 497.15lin.m x 0.15 thk Road [485.80lin.m x 5.00m; 7.65lin.m x 9.00m; 3.70lin.m x 7.50lin.m; (1/2) (2.00m x 3.00m) (2)] & Construction of 3 units – 1.40m x 1.20m x 9.00lin.m Box Culverts and Demolition of 1 unit – 30”dia x 7.00lin.m RC Pipes with Headwall & 2 units – 24”dia x 7.00lin.m RC Pipes*. Completion of the Works is required *within ninety (90) calendar days*. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from **LGU VILLAVERDE, Poblacion, Villaverde, Nueva Vizcaya** and inspect the Bidding Documents at the address given below from **8:00a.m. – 5:00 p.m., Monday - Friday**.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **Three Thousand Pesos Only (P3,000.00)** starting on May 19, 2015 to June 10, 2015.

It *may also be downloaded* free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

6. The **LGU VILLAVERDE** will hold a Pre-Bid Conference on **May 27, 2015 at 2:00 P.M. at the Municipal Function Hall, Poblacion, Villaverde, Nueva Vizcaya**, which shall be open to all interested parties.
7. Bids must be delivered to the address below on or before **June 10, 2015 at 10:00 A.M. at the Municipal Function Hall, Poblacion, Villaverde, Nueva Vizcaya**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.


Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. Prospective Bidders should possess a valid PCAB License Applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility forms) available for the prosecution of the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids. The BAC will conduct post-qualification of the lowest calculated bid.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

9. The **LGU VILLAVERDE** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
