**Invitation to Bid for the
CONSTRUCTION OF TRADING POST**

1. The *LGU VILLAVERDE*, through the *Department of Agriculture Fund & 20% MLGU Development Fund* intends to apply the sum of *Four Million One Hundred Ninety Nine Thousand Nine Hundred Fifty Six Pesos & 32/100 (P 4,199,956.32)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *CONSTRUCTION OF TRADING POST*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *LGU VILLAVERDE* now invites bids for *Construction of 13units – 4.00m x 6.00m Trading Posts & 4.00m x 6.00m Entrance w/ Shed and Demolition of 6.00m x 52.00m Existing Market Stalls*. Completion of the Works is required within *One Hundred Eighty (180) calendar days*. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested bidders may obtain further information from *LGU VILLAVERDE, Poblacion, Villaverde, Nueva Vizcaya* and inspect the Bidding Documents at the address given below from *8:00a.m. – 5:00 p.m., Monday - Friday*.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *Five Thousand Pesos Only (P5,000.00)* starting on June 26, 2015 to July 17, 2015.
6. The *LGU VILLAVERDE* will hold a Pre-Bid Conference on *July 3, 2015 at 2:00 P.M. at the Municipal Function Hall, Poblacion, Villaverde, Nueva Vizcaya*, which shall be open to all interested parties.
7. Bids must be delivered to the address below on or before *July 17, 2015 at 10:00 A.M at the Municipal Function Hall, Poblacion, Villaverde, Nueva Vizcaya*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.


Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. Prospective Bidders should possess a valid PCAB License Applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC, and have key personnel and equipment (listed in the Eligibility forms) available for the prosecution of the contract. The BAC will use non-discretionary pass/fail criteria in the Eligibility Check/Screening as well as the Preliminary Examination of Bids. The BAC will conduct post-qualification of the lowest calculated bid.

All particulars relative to Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. 9184 and its Implementing Rules and Regulations (IRR).

9. The **LGU VILLVERDE** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
